# Homes for All Massachusetts Priority Legislation 2025-26

### An Act enabling cities and towns to stabilize rents and protect tenants

<u>S.1447 (Sen. Jehlen & Sen. Gomez) / H.2328 (Rep. Dave Rogers & Rep. Montaño)</u> This bill would repeal the ban on rent control and enable municipalities to enact local rent control ordinances to stabilize housing costs and prevent no-cause evictions.
